Proposal Context

Project Location

Westgate Street, between Westgate House and Marlborough House in the vicinity of Quay Street.

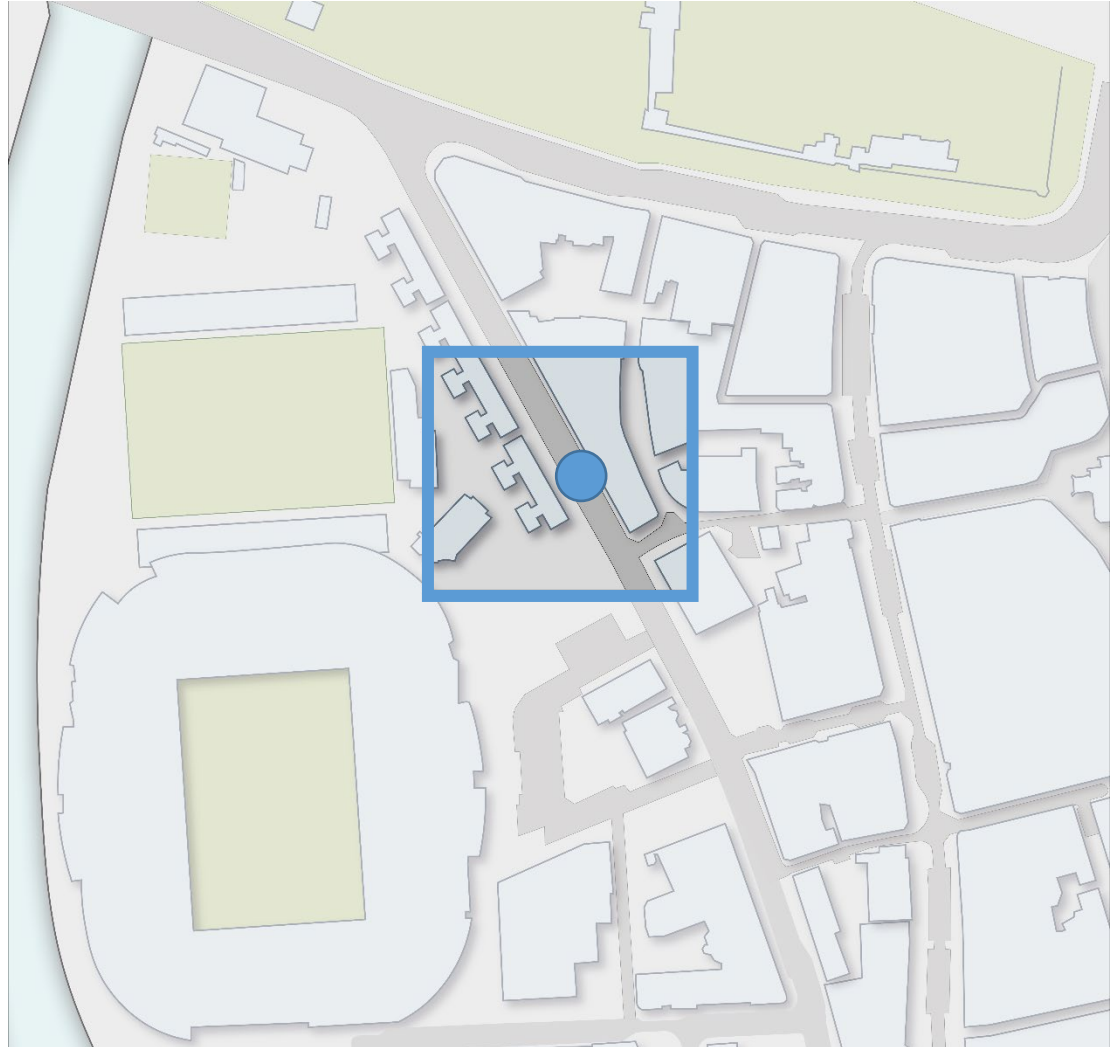
What are we doing?

Cardiff Council is developing proposals for a new pedestrian crossing on Westgate Street.

This crossing will replace the temporary pedestrian crossing on Westgate Street, near the junction with Quay Street with a permanent crossing.

Why is this needed?

The temporary crossing was put in place to assist pedestrians on Westgate Street after the main crossing outside of the car park and entrance to the stadium was decommissioned to allow extra room for bus stops and loading vehicles.



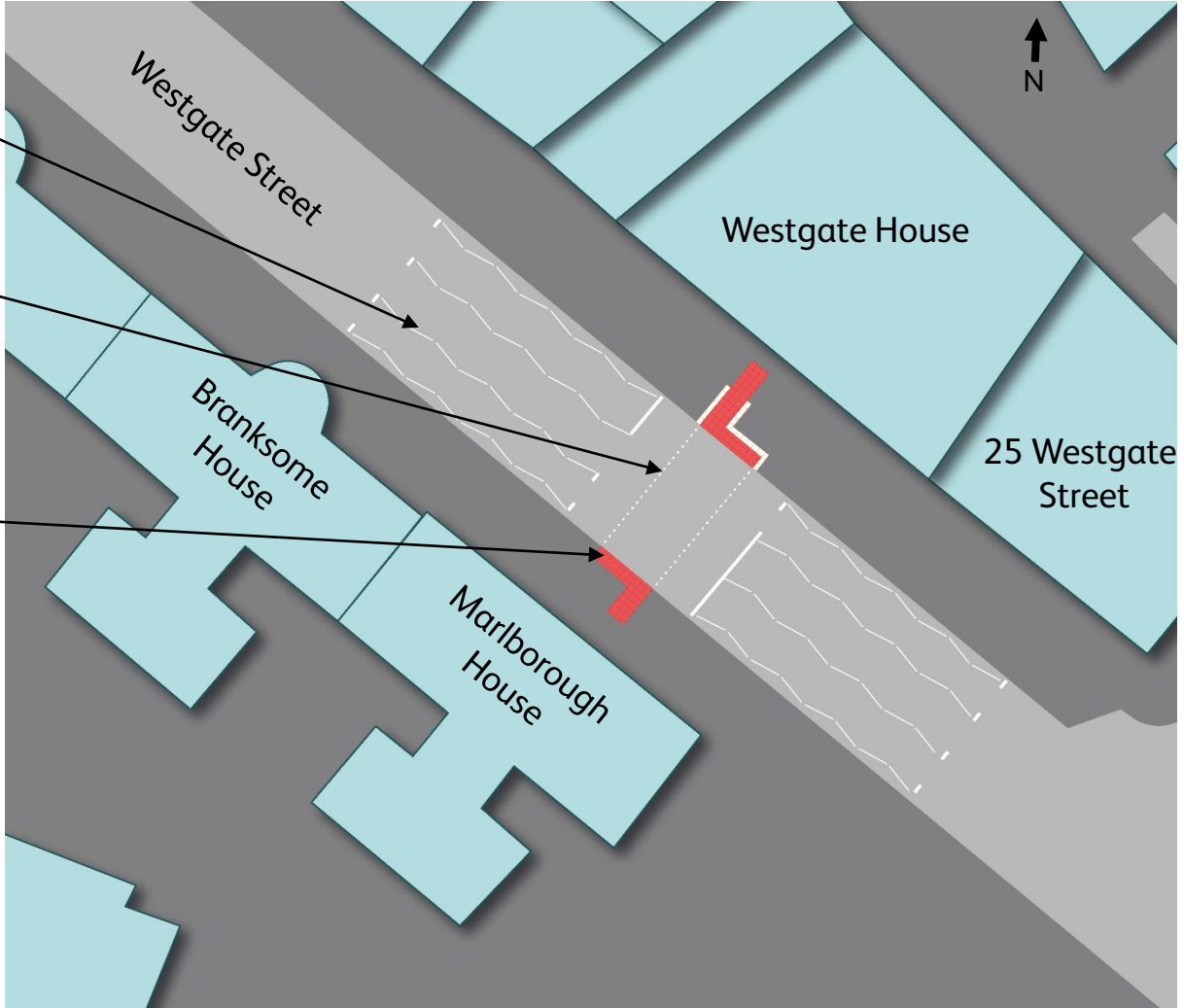
Westgate Street Pedestrian Crossing

Frequently Asked Questions

How is this project funded?

Funding for this project comes from the Local Transport Fund.

Will loading be affected?

All loading currently in place will be unaffected except for the zig-zag marked areas adjacent to the crossing. All businesses are advised to load from the designated loading bays on the street.

Will the bus lane be affected?

Bus lanes will not be affected by this scheme.

Will bus stops be affected?

There will be no impact on bus stops.

Will the crossing have an audible signal?

Due to the close proximity to residences there will be no audible signal on the crossing.

Will the crossing impact traffic?

Traffic levels will be unaffected.

Why can't the funding be used to fill in potholes?

The Council receives separate funding to address maintenance issues.
